Sterling Office and Industrial Trust Acquires Tracks Industrial (West Fargo, ND)

FARGO, NORTH DAKOTA – Sterling Office and Industrial Trust announced its operating partnership, Sterling Office and Industrial Properties, LLLP, successfully acquired the Tracks Industrial property, a 202,500 square foot industrial warehouse and logistics facility in West Fargo, North Dakota, for an acquisition price of \$19,700,000. The transaction was funded using cash and internal 1031 proceeds. The acquisition closed on January 15, 2026.
